EVENT RULES These rules are subject to revisions without prior notice.

ELIGIBILITY The competition is open to all law enforcement officers / first responders who are currently certified to operate a police motorcycle, including retired motor officers. Participating competitors are allowed to compete in one of the following classes.

COMPETITION CLASSES

- (1) Novice:
 - a. Any competitor who has competed in three or less police motorcycle competitions and has never placed individually in the top 5 at any police motorcycle competition, including retired motor officers.
- (2) Expert:
 - a. Any competitor who has competed in more than three police motorcycle competitions or has placed in individually in the top 5 at any police motorcycle competition, including retired motor officers.
- (3) Retired Officer:
 - a. Retired Peace Officers no longer serving in a law enforcement capacity are eligible regardless of class or division.
 - i. Confirm entry into this category upon registration.
 - ii. Retired officers are not eligible for Mr./Mrs. Rodeo and can only place in individual/team events.
- (4) ***Any competitor can choose to ride in the Expert class, but cannot go back down once they have chosen to move up.***

MOTORCYCLE DIVISIONS **A competitor may only compete in one division**

- (5) Division 1 –
 - a. Harley Davidson Road King (Windshield)
- (6) Division 2 –
 - a. Harley Davidson Electra Glide (Fairing)
- (7) Division 3 –
 - a. Harley Pan American, BMW, Honda, and Kawasaki

MOTORCYCLES

- (8) Competition Motorcycle Requirements
 - a. Competitors must compete on a police motorcycle of at least 1000 cc's that is equipped with standard equipment used for their normal course of duty.

- b. No modifications or removal of standard equipment will be allowed with the exception of the side stand; this includes
 - i. removal of lights, reflectors, saddle bags, engine guards, radio boxes, etc.
 - ii. All motorcycles are subject to random inspections.
- (9) Emergency Motorcycle Repairs
 - a. Prior to entering an event, a competitor (or team) will be allowed 15 minutes to repair a motorcycle that is malfunctioning. If the motorcycle is unserviceable, the competitor may continue in the competition provided that:
 - i. The competitor can locate a replacement motorcycle within 15 minutes.
 - 1. The new motorcycle must already be qualified.
 - b. The motorcycle must be assigned to compete in the same division as the competitor.
- (10) Motorcycle Malfunctions Once a competitor or team has begun an event
 - a. no excuses for a breakdown will be allowed. This includes side stand problems. It may be advantageous to secure or remove the side stand prior to competing.

CLOTHING AND CONDUCT

- (11) Competitors must dress appropriately. Boots, helmet, and eye protection must be worn at all times during practice and competition.
- (12) Standard duty uniform must be worn on Friday, as this will be the start of the competition.
- (13) All competitors shall act in a professional manner. Inappropriate behavior could result in disqualification from the competition.
- (14) The competition and practice tracks will be closed from 08:00 PM-06:00 AM.
 - a. Any competitor found in violation will be provided with a warning on their first offense and is subject to disqualification on future violations.

RULES COMMITTEE DEFINED:

- (15) A Rules Committee will be established on day one of the SCOTMR to settle all disputes that may arise during the competition that cannot be settled at the judges' level.
- (16) The committee will also be responsible for making the final determination on when/if a competitor will be able to compete at an alternate time if an exigent circumstance arises and he/she is unable to compete in their assigned slot.
- (17) The Rules Committee will be comprised of three to five members from different agencies selected by the Head Track Official and posted on or near the registration booth. Each member has a vote, and the majority vote rules.
- (18) A representative from the affected agency may be involved in any discussion leading up to a vote but may not cast a vote to resolve the dispute.

DISPUTES:

- (19) Disputes will be handled in the following manner:
- a. Any dispute of scoring of a particular event must be addressed by the affected competitor after completing said run.
 - b. Only the competitor may dispute scoring or a judge’s decision.
 - c. Disputes will be brought to the presiding track Judge for ruling over a course score.
 - d. If the dispute is not resolved by the lead track Judge, the Rules Committee will resolve the dispute.
 - i. Should the Rules Committee not agree on a decision, the director will then determine final action.
 - e. All decisions of the Rules Committee are final.

ONSITE REGISTRATION & TCOLE CREDIT

- (20) Registration will be limited to 120 registrants
- (21) All competitors must complete and sign the waiver form at registration/check-in.
- (22) When paperwork is submitted, each competitor will randomly draw a competitor number.
- a. The competitor number which must be displayed on the competitor's motorcycle throughout the competition.
- (23) Each registered competitor will be supplied with a packet which will include an itinerary of all events, rules sheet, and information pertaining to evening events.
- (24) Competitors may sign up for individual and team events during onsite registration.
- (25) Texas competitors wishing to receive TCOLE credit will be required to sign a Round Rock Police Department training roster and complete an evaluation at the completion of the event.
- a. Both must be received for credit to be given.
 - b. Evaluations will be provided at onsite registration or via email after the competition.

MANDATORY COMPETITOR’S MEETING

- (26) A meeting of all competitors riding in the Motorcycle Rodeo will be held prior to the start of the competition.
- a. The scoring and the approved path of travel through the events will be reviewed and demonstrated.
 - b. Competitors should understand course events prior to the end of the meeting.
 - c. The meeting will be conducted by the Head Track Judge or designee.
 - d. The competitors meeting time will be provided at onsite registration, in the itinerary.
 - e. It is the competitor’s responsibility to attend the mandatory meeting.
 - f. After the competitors’ meeting, any disputes concerning information disseminated at the competitors’ meeting will not be considered.

- i. At the completion of the competitors meeting the tracked will be considered as “set” and will not be altered thereafter.

COMPETITION EVENTS

- (27) For all events, unless otherwise noted, competitors will compete in numerical or reverse numerical order as determined by the Lead Track Judge.
- (28) If exigent circumstances arise that prevent a competitor from competing in the assigned slot the competitor must bring the issue to attention of Lead Track Judge.
- (29) The Lead Track Judge will convene the Rules Committee for a ruling based on the specific set of circumstances.

COURSE PENALTIES

- (30) SCORING:
 - a. Cone disturbed/knocked down:
 - i. plus two (2) seconds
 - b. Putting a foot down:
 - i. plus four (4) seconds
 - c. Bike down:
 - i. plus five (5) seconds
 - d. Run out of pattern (Re-enter at same location):
 - i. plus eight (8) seconds
 - e. Improper path/direction through pattern (not corrected):
 - i. plus twenty (20) seconds
 - f. Improper path/direction through pattern (corrected at point of error prior to finishing the exercise):
 - i. no penalty
 - g. Did Not Finish (DNF):
 - i. plus one hundred (100) seconds
 - h. Fail to Enter exercise:
 - i. Disqualification
 - i. Short Coursing:
 - i. Disqualification

MAIN COMPETITION (Tracks A & B)

- (31) The main competition will consist of one run on each of the speed courses; runs will be timed. Times with penalties will be combined for one total to include any assess penalties. The quickest time, after penalties wins.

- a. If a competitor has a “clean run” on each course, there will be 2 seconds deducted from the total combined time. Must be “clean run” on all courses.
- (32)The timed runs will begin when the competitor’s front tire breaks the electric eye of the timer and end when the front tire breaks the electric eye of the timer when exiting the last exercise.
- a. A back up stopwatch will be used by the Head Track Judge or designee.
- (33)Competitors will be randomly given a competitor number.
Competitors with even numbers will receive an additional run on course A, competitors with odd numbers will receive an additional run on course B.
This draw will signify which course they will get an additional run on. The fastest run including penalties will be used and the other time will be thrown out.
- (34)FINAL SCORE:
- a. Final score will consist of each competitor’s combined time as noted above, with penalties for one time (in seconds). The fastest time after penalties are assessed is the winner.
 - b. TIE:
 - i. In the event of a tie the tie will be broken with the competitor who has the least combined penalties in the Main Competition to include all courses (if applicable).
 - c. AWARDS:
 - i. The top 10 riders will be recognized in each class and division.

INDIVIDUAL SLOW RACE GOAL

- (35)Competitors will negotiate the designated course for the slowest time. Slowest time will win.
- a. Each officer will receive one free attempt and may buy in up to four additional attempts at \$5.00 per attempt.
 - i. Each officer will be allotted up to 5 attempts
- (36)The time starts when the competitor’s front tire crosses the start line.
- (37)The time ends when the competitor’s rear tire crosses the end line.
- (38)Competitors may compete at any point during the competition when the Slow Race track is open.
- (39)SCORING:
- a. The competitor’s time will stop at the occurrence of any of the following;
 - i. A competitor puts a foot down,
 - ii. A competitor drops the motorcycle in the space, and/or
 - iii. A competitor crosses the boundary line, and/or
 - iv. A competitor touches a cone.
- (40)AWARDS:
- a. Top 10 competitors for each class and division will be recognized.

THE ELIMINATOR/DRAW RACE, HEAD-TO-HEAD:

- (41)The drag race is a single elimination. There will not be any “buy-ins” or second runs.
 - a. Competitors will be placed into a bracket at random.
- (42)The two competitors will enter the pattern containing obstacles and designated path.
 - a. The winner of a coin toss will be given the choice of pattern one (left looking into pattern) and two (right). The elder of the two riders will call the coin flip.
- (43)The competitor numbers are selected at random and applied to the bracket by the Lead Track judge.
- (44)Competitor must be available when their number is called, missed turns will result in elimination.
- (45)The event will start by a track judge verifying each rider is ready. Once both riders acknowledge they are ready the judge one or both hands pause then drop them.
 - a. competitors may begin the course when the hands move from the raised position.
- (46)Start with wheel on designed line.
- (47)Winner is first tire to cross exit line. Must come to a stop in stop box area.
- (48)The competitor on course 1 will make right U-turn, move to far cone and make left U-turn, then move to the middle cone, the competitor will complete a 360 turn of their choice and move to finish.
- (49)Competitor on course 2 will complete a mirror of course 1. left U-turn, right U-turn, 360 in direction of choice prior to finish line.
- (50)After the riders exit the course, they are required to stop prior to a stop line (box)
- (51)Either competitor may be eliminated by hitting a cone or putting a foot down or running out of the pattern.
 - a. To win your race you must not have any faults and complete your course.
 - i. Should a rider exit the pattern prior to crossing the “finish” line, this action will be considered “out of pattern” and a violation resulting in disqualification of that competitor.
 - b. Any fault regardless of when it occurs will be considered an elimination. Cone disturbance, foot down, bike down, out of pattern, improper path, DNF, striking stop box cones, etc...
- (52)If any contact is made between the two motorcycles, the competitor determined to have initiated the contact will be eliminated.

AWARDS:

- a. Only first place will be awarded, regardless of class or division.

PARTNER RACE:

- a. GOAL:

- i. The Partner Race will consist of two riders.
- ii. The two riders will enter a designated exercise with one rider leading and the other following.
- iii. The time starts when the first rider's front tire breaks the electric eye of the timer and ends when the front tire of the last rider breaks the end line of the timer when exiting the last exercise.
- iv. A stopwatch will be used by the Head Track Judge or designee.

(53)FINAL SCORE:

- a. Final score will consist of the total time taken for all officers to complete the exercise.
- b. The fastest time after penalties assessed, wins.

(54)TIE:

- a. In the event of a tie, the tie will be broken with the competitor who has the cleanest run.

(55)AWARDS:

- a. The top 10 teams will be recognized in each class and division.

(56)Four-man and two-man:

- a. GOAL:
 - i. The team events will consist of two or four riders.
 - ii. The riders will enter a designated exercise with one rider leading and the other three riders following.
 - iii. The time starts when the first rider's front tire breaks the electric eye of the timer and ends when the front tire of the last rider breaks the end line of the timer when exiting the last exercise.
 - iv. A stopwatch will be used by the Head Track Judge or designee.
 - v. The course descriptions will be given during the competition week.

(57)FINAL SCORE:

- a. Final score will consist of the total time taken for all officers (the entire team) to complete the exercise.
- b. The fastest time after penalties assessed, wins.

(58)TIE:

- a. In the event of a tie, the tie will be broken with the competitor who has the cleanest run.

(59)AWARDS:

- a. The top 10 teams will be recognized in each class and division.

(60)Memorial Challenge Ride

- a. GOAL:

- i. Each competitor will negotiate a predetermined course consisting of advanced skills usage (brakes, no brakes, etc.) for time.
- ii. This course will not be available for practice and will be unknown to competitors until the time of event.
- iii. Fastest time will win.

(61)AWARDS:

- a. Top 3 riders will be recognized, regardless of class or division.
- b. This event is required for all officers competing for Best Overall Team and Mr. Rodeo.

ADDITIONAL AWARDS

- c. Mr. Rodeo / Overall Individual (Harley/Victory):
 - i. Competitor must compete in Main Competition (all tracks), Memorial Challenge Ride, and Slow Race.
 - ii. The scores from the events will be used to determine the winner within the Harley/Victory grouping.
 - iii. The competitor’s individual course times and challenge time will be added together for a total speed time.
 1. (5) percent of the competitor’s slow race time will be taken off the total speed time.
 2. Awarded to competitor with the lowest overall time, regardless of class or division.
 3. Only riders on Harley Davidson and Victory Motorcycles are eligible for this award. 1st – Mr. Rodeo and 2nd and 3rd awarded.

(62)Tie:

- a. In the event of a tie, the tie will be broken with the competitor who has the least combined penalties in the Main Competition: to include, Courses A and B and the Memorial Challenge Ride.
- b. If competitors are still tied, the tie will be broken with the competitor with the fastest Final Score (includes penalties) in the Memorial Challenge Ride.

(63)Mr. Rodeo / Overall Individual (Metric / Goldwing):

- a. Competitor must compete in Main Competition (all tracks), Memorial Challenge Ride, and Slow Race.
- b. The scores from the events will be used to determine the winner within the Metric / Goldwing grouping.
- c. The competitor’s individual course times and challenge time will be added together for a total speed time.
- d. (5) percent of the competitor’s slow race time will be taken off the total speed time. Awarded to competitor with the lowest overall time, regardless of class or division.

- e. Only riders on Metrics and Gold Wings are eligible for this award. 1st – Mr. Rodeo and 2nd and 3rd awarded.

(64)Tie:

- a. In the event of a tie, the tie will be broken with the competitor who has the least combined penalties in the Main Competition: to include, Courses A and B and the Memorial Challenge Ride.
- b. If competitors are still tied, the tie will be broken with the competitor with the fastest Final Score (includes penalties) in the Memorial Challenge Ride.

(65)Best Overall Team Award:

- a. All team members must compete in the Main Competition (all courses), Memorial Challenge Ride and Slow Ride.
- b. Overall Team score is a cumulative total of each team members overall ranking in each of these three events regardless of class or division.
 - i. These teams must be declared at registration
 - ii. Should a team member become unable to compete or withdraws, substitutions must be declared.
- c. Top 10 teams will be recognized.

GLOSSARY OF TERMS

(66)Clean Run –

- a. a completed course run without any penalties.

(67)Competitor –

- a. a Law Enforcement Officer who is authorized to ride a Police Motorcycle by their department and is registered to compete in the Capital of Texas Police Motorcycle Chute Out.

(68)Course or Exercise –

- a. a series of events which a competitor must ride; includes the path of travel between exercises in the individual timed runs.

(69)Department:

- a. Any Law Enforcement agency whom a competitor is a member/employee.

(70)Drop the Motorcycle:

- a. In an exercise, if the motorcycle falls to the surface and the competitor does not have control of the motorcycle, which would allow for safe operation of the motorcycle. (includes any part of the entire course).

(71)Foot Down:

- a. In an exercise, whenever a competitor’s foot comes in contact with the surface (includes any part of the course during the timed runs).

(72)Judge:

- a. A person designated to score and/or time a competitor on the course.
- (73) Judge’s Meeting:
- a. A meeting of course judges to review rules and scoring procedures of the Motorcycle Chute Out.
- (74) Cone disturbed:
- a. Whenever any part of the motorcycle or competitor hits any part of a cone which causes the cone to fall over or be displaced from its original position or if a judge has to physically move or reposition the cone.
- (75) Running Out of Exercise:
- a. When the front and rear wheels cross the imaginary line between the center points of the two adjacent cones where the motorcycle would not normally enter or exit an event. In events which use a boundary line, if the tire contact patch crosses the boundary line, the competitor has run out of the exercise.
- (76) Short Coursing:
- a. The act of cutting a course short or omitting required sections of the course where the end result is a time advantage for the competitor.
- (77) Touch a Cone:
- a. Whenever any part of the motorcycle or competitor touch any part of a cone.
- (78) Usage of Brake:
- a. Whenever any braking is done throughout the course, determined by brake lights.
- (79) Gate cone:
- a. Any cone that is identified by the Rules Committee as a “gate” (These cones are identified during the mandatory meeting and track walk through). A gate cone signifies the exit of one portion of the course and the entry into the next phase.
